

Home quarantine leh Hotel quarantine dil duh tan online-in <https://mcovid19.mizoram.gov.in>-ah a dil theih tawh bawk.
- 2) State pawn atanga thlawhna emaw lirthei emawa lo lutte hian VLTF/LLTF te hriatpuina lehkha lak ve kher a ngai lo vang. Mizoram an luhna atana *mPass*-a an in register-na chu an thlenna tur (destination) thlen nan pass angin an hmang thei ang a, hmun dang kalkual/tlawhkual nan *mPass* chu hman phal a ni lo.
