ORDER

Tunlai COVID-19 vanga inkharkhipna kal zelah, Lawngtlai District huam chhunga in sak, retaining wall sak, kawng laih etc ngaite chuan a hnuai tarlan ang hian dilna an siam tur a ni ang:-

1. In sak leh retaining wall etc siam tumte chuan an in sakna tur/ retaining wall etc siamna tur awmna veng VLTF-te hnenah ziakin an inhriattir tur a ni ang. VLTF-te chuan an dilna chu an khawn khawm anga, a hmunah ngei an en sak (verify) tur a ni ang a, tul bik tak tak, sak/siam chhunzawm loh chuan mi dang tan hlauhawm thei etc te chauh 'recommend-na' an siam sak ang a, chungte VLTF-te chuan mahni bialtu Incident Commander-te theuh hnenah an theh lut ang a, Incident Commander-ten DC Lawngtlai hnenah an hlan chhawng ang. Hetiang dilna hi VLTF-ten a hlawmin ni 25.04.2020 aia tlai lovah Incident Commander-te hnenah an theh lut tur a ni ang.

He thilah hian sawi tawh angin a tul bik tak tak lo chu recommend loh tur a ni ang a, induhsak vanga recommend na lo pek maite tih loh tawp tur a ni ang. Hei hian company leh private contractor-te a huam lovang.

2. In sak leh retaining wall etc siam phalna hi VLTF-ten an pe thei lova, dilna *verify* hnuah an *recommend* thei chauh zawk a ni. ***Phlana erawh DC Lawngtlai chauhin a pe ang.***
3. Company leh private contractor-te erawh chuan phalna hi DC Lawngtlai hnenah an dil ang. Hemi atana hian Nodal Officer Pu Vanlalbiakzauva, SDC hnenah dilna hi an ngaihven tur a ni ang.
4. In sakna tur/ retaining wall siamna hman tur etc bungraw lak khawm leh dah kual phalna hi DC Office Lawngtlaiah dil tur a ni ang. An dilnaah a hnuai tar lan ang hi Chiang takin a ziaik tur a ni bawng ang:

6. Hlawhfa chhawr theih hun chhung hi Thawhtan to Inrinni (Monday to Saturday) zing dar 9 atanga tlai dar 5 (09:00 am to 05:00 pm) thleng a ni ang.
