Mizoram sawrkar in ni 08.01.2022 atanga ni 31.01.2022 thlenga Mizoram chhunga Covid-19 inkaihhraina kalpui dan tur inkhuahkhirhna thupek vide *No. B.13021/101/2020-DMR/Vol-VI dt 07.01.2022*-a a chhuah behchhanin a hnuai mi ang hian Aizawl District chhung atan ruahmanna siam a ni a. **He inkaihhraina-in a sawilan loh ah te chuan State sawrkar-in order/inkaihhraina (SOP) a tihchhuah anga kal tur a ni.** Hrileng laka kan him zawk nan a hnuai tarlan te hi mipuin zawm ngei tur a ni.
