**ORDER**

Whereas, the Central Government, in exercise of powers conferred by section 3(1) of the Unlawful Activities (Prevention) Act, 1967 (37 of 1967), has declared the Popular Front of India (PFI) and its associates or affiliates or fronts, including Rehab India Foundation (RIF), Campus Front of India (CFI), All India Imams Council (AIIIC), National Confederation of Human Rights Organization (NCHRO), National Women's Front, Junior Front, Empower India Foundation and Rehab Foundation, Kerala as unlawful association vide notification number S.O. No. 4559(E) dated 27<sup>th</sup> September, 2022;

And whereas, in exercise of the powers conferred by section 42 of the said Act, the Central Government has directed vide Notification No. S.O. 4560 (E) dated 28<sup>th</sup> September, 2022 that all the States and Union Territory Administrations shall exercise the powers exercisable by the Central Government under sections 7 and section 8 of the said Act;

And whereas, vide Order No. 14017/4/2022-NI-MFO dated 28<sup>th</sup> September, 2022 (Copy enclosed) it has been conveyed that the State Governments and Union Territory Administrations may, by order in writing, direct that any power which has been directed to be exercised by it, shall, in such circumstances and under such conditions, as may be specified in the direction, be exercised by all District Magistrates / Deputy Commissioners and all District Superintendents of Police under the Government of Mizoram.

Now, therefore, in exercise of the aforesaid delegated powers, the State Government hereby directs that all District Magistrates / Deputy Commissioners and all District Superintendents of Police shall exercise the powers accordingly.
