- ✓ In hriat angin sawrkar thar chuan thlai pali-Sawhthing, Aieng, Hmarcha leh Hmunphiah te kuthnathawktu ten man man zawka an hrall theih nan Support Price a siama, chu support price aia to a an hrall theihna turin a hralthna (market) a theih ang angin hma a lak pui dawn a ni.
- ✓ Thlai thar lei chungchanga sawrkar tum ber pakhat chu a thartute leh a leitute awmze nei zawka an in dawr tawn theih nana a market linkage siam sak a ni.
- ✓ Kum thum chhung hian mumal taka market linkage siam hman kan tum a, kum thum hnuah chuan sawrkar a inrawlh vak ngai tawh lo tura sumdawngte leh thlai thartute an indawr theih tawh kan beisei.
- ✓ Kum tharah hian heng tlai pali zingah sawhthing hi quintal nuaih sawm (10 lakh quintals) chuang thar tura beisei a nih avangin, a hrall dan tur ruahmanna chi thum kan siama, chungte chu:

### **Tender/Auction system:**

  - A ruala sawhthing kan chawh huk chuan market-ah kan hnawng nghal dawn a, chuvangin a chawh hun thuah pawh in sem zai deuh a ngai dawnna, a tul angin sawrkarin ruahmanna a la siam anga, kan tan rual a ngai viau dawn a ni.
