1. AMC area chhunga in, office, playground, vantlang zunin sa tur te chuan Site Development & Slope Modification (SD&SM) hnuiah AMC ah phalna la in, a hmunhma 45 degree aia awih ah chuan Slope Stability Analysis report an nei ngei ngei tur a ni. Report ah hian a hnuiai tarlan te hi a tel tur a ni:
  - a) Plasticity index
  - b) Direct Shear Test
  - c) Standard Proctor Compaction Test
  - d) Soil Bearing Capacity
  - e) Specific Gravity
  - f) Porosity.

7. Aizawl khawpui chhung leh khaw dai a Quarry nei ten Directorate of Geology & Mining atangin Mining/ Quarring Plan an nei ngei ngei tur a ni a, Plan ang hian hma an la tur a ni. A tlem thei ang ber lung hal tur a ni a, nghawr na lo thei ang tur leh a bulhnai leilung ti che tlem thei tur ang berin Engineer-te enpui na hnuaih Scientific blasting hman tur a ni. Shotfirer License nei lo in tumah lung hal phal a ni lo.
