

WHEREAS, the scat of Pu Laiduhoma, in the Legislative Assembly of the State of Mizoram, elected from 26-Serchhip (ST) Assembly Constituency has become vacant on 27.11.2020, by reason of his becoming subject to disqualification under clause (2) of Article 191 of the Constitution of India read with the Tenth Schedule thereto; and

- 2. WHEREAS, a bye-election is to be held for the purpose of filling the vacancy so caused;
- 3. NOW, THEREFORE, in pursuance of Section 150, 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby -
- Calls upon the said 26-Serchhip (ST) Assembly Constituency in the State of Mizoram, to elect, before the 04.05,2021 (Tuesday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person belonging to any of the Scheduled Tribes of the State, for the purpose of filling the said vacancy in the Legislative Assembly of the State.
- appoints, with respect to the said election,-(a) the 30th March, 2021 (Tuesday), as the last date for making nominations; (b) the 31"March, 2021 (Wednesday), as the date for the scrutiny of nominations;
  - (c) the 3rd April, 2021 (Saturday), as the last date for the withdrawal of candidatures;
  - (d) the 17th April, 2021 (Saturday), as the date on which a poll shall, if necessary, be taken; and (e) the 04"May, 2021 (Tuesday), as the date before which the election shall be completed; and
- fixes the hours from 07.00 AM to 06.00 PM, as the hours during which the poll shall, if necessary, be taken on the date specified above, for the election.

### 1. ELECTORAL ROLL

The Electoral Rolls for the aforesaid Parliamentary and Assembly Constituencies w.r.t 01.01.2021 as the qualifying date has been finally published.

# 2. ELECTRONIC VOTING MACHINES (EVMs) and VVPATs

The Commission has decided to use EVMs and VVPATs in these bye-election in all polling stations. Adequate numbers of EVMs and VVPATs have been made available and all steps have been taken to ensure that the polls are conducted smoothly with the help of these machines.

# 3. IDENTIFICATION OF VOTERS

In continuance to the existing practice, the voter's identification shall be mandatory in the aforementioned election at the time of poll. Electoral Photo Identity Cards (EPIC) shall be the main document of identification of a voter. However, in order to ensure that no voter is deprived of his/her franchise, if his/her name



figures in the electoral rolls, following alternate identity documents are also prescribed:

- i. Aadhar Card,
- ii. MNREGA Job Card,
- iii. Passbooks with photograph issued by Bank/Post Office,
- iv. Health Insurance Smart Card issued under the scheme of Ministry of Labour,
- v. Driving License,
- vi. PAN Card,
- vii. Smart Card issued by RGI under NPR,
- viii. Indian Passport,
- ix. Pension document with photograph,
- x. Service Identity Cards with photograph issued to employees by Central/State Govt./PSUs/Public Limited Companies, and
- xi. Official identity cards issued to MPs/MLAs/MLCs.

#### 4. MODEL CODE OF CONDUCT

Model code of conduct shall come into force with immediate effect in the district(s) in which the whole or any part of the Parliamentary/Assembly constituency going for election is included, subject to partial modification as issued vide Commission's instruction No. 437/6/1NST/2016-CCS, dated 29th June, 2017 (available on the commission's website <a href="https://eci.gov.in/">https://eci.gov.in/</a>) (copy enclosed). The Model code of conduct shall be applicable to all candidates, political parties and the State government concerned. The Model Code of Conduct shall also be applicable to the Union Government also.

#### 5. VOTER INFORMATION SLIPS (VIS)

To facilitate the voter to know the serial number of electoral roll of his/her polling station, date of poll, time etc., the Commission vide letter dated 26.02.2021, has decided to issue Voter Information Slip' to the voters in place of Photo Voter Slip. Voter Information Slip will include information like Polling Station, Date, Time etc. but not the photograph of the voter. Voter Information Slip will be distributed at least 5 days before the date of poll to all enrolled electors, by the District Election Officer. However, Voter Information Slip will not be allowed as proof of identity of voters. It may be recalled that the Commission had discontinued Photo Voter Slips as an identity proof with effect from 28th February, 2019.



# 6. BROAD GUIDELINES TO BE FOLLOWED DURING THE CONDUCT OF BYE-ELECTIONS DURING COVID-19

In view of spread of COVID-19, the Commission on 21st August, 2020, issued broad guidelines, which is to be followed strictly during the conduct of elections, which is available on Commission's website.

All instructions issued during General Election to Legislative Assemblies of Bihar, 2020 and General Elections to Legislative Assemblies of 5 States/UT shall also be mutatis mutandis applicable to the aforementioned bye-elections.

Subject:- Model Code of Conduct- Instructions- bye-election of Parliamentary/Assembly Constituency -regarding. Sir,

On the above cited subject, I am directed to state that the Commission has reviewed the issue and has issued the following modifications of its earlier instructions-

1. Enforcement of MCC

The Commission's instructions, contained in letters No. 437/6/INST/2012/CC&BE dated 26.04.2012 and No. 437/6/INST/2012/CC&BE dated 21.10.2013, list various provisions of applicability of MCC to the concerned district or the AC/PC concerned. These instructions are modified to the extent that in case the constituency is comprised in State Capital/Metropolitan Cities/Municipal Corporations, then oforesaid instructions would be applicable in the area of concerned Constituency only. In all other cases the MCC would be enforced in the entire district(s) covering the Constituency going for bye-election(s).

2. Publishing of Advertisements

The Commission on 25th June, 2013, directed that the release /publishing of advertisements during the period of operation of Model Code of Conduct in connection with bye-elections would be regulated as follows:-

Advertisement of general nature in connection with specific occasions of importance may be published. However, such publishing shall be restricted to the dates coinciding with the special occasion only, and it shall not be published on other days. The advertisement shall not bear photographs of any Minister and other political functionaries.

No advertisement having any specific/pointed reference or connotation to the areas covered by (ii) the bye-election constituencies shall be released/published on any date during the period.

Further, It is clarified that no new schemes should be advertised in the districts where the byeelection is being conducted. [Subpara (ii) above) stands modified].

3. Tours of Ministers

During bye elections from any constituencies, either Parliamentary or Assemblies, the following restrictions are applicable as per instruction issued by the Commission on 23rd November, 2007 with regard to the tours of Ministers which inter alia provides that:-

(I) All Ministers, whether Central or State, shall not combine in any manner their official tours with election work after the announcement of the bye elections. All and any visits to the district(s) where bye-election is being held and where Model Code of Conduct is, therefore, in force, have to be completely private in nature.

(ii) In case where a Minister travelling on official work transits through the district(s) where the byeelection is being held en route to any other district on official visit, he shall not attend to any political work.

Further, It is clarified that the Ministers or persons holding equivalent rank/status cannot combine their official visit with campaign by en routing their journey for official purposes to a place where MCC is not in force and then proceeding from that place to the area where MCC is in force for election campaign. In case it is done, the entire journey expense shall be treated as election expense. [subpara (ii) above stands modified).

Greater participation for a stronger democracy



#### 4. Regarding Transfer/Posting of Officers

For all officers, who are connected with the conduct of bye-election in the State, the existing ECI's instructions on implementation of transfer policy be applied within the area falling under the concerned AC/PC. While implementing this policy the DEO/RO should take care that in case of deployment of any officer from outside the constituency for any election related duty, shall also conform to the transfer policy of the Commission.

#### 5. Regarding Announcement of D.A.

There is no ECI's instruction in the context of bye-election prohibiting State Governments to take decisions which have State wide effect and consequently in the Constituency concerned.

The Commission, after taking into consideration all relevant factors in this regards, has decided that announcement of D.A. by the state government may be done as a routine affair but it should not be publicized as the Government's achievement.

Kindly inform all concerned and give due publicity and ensure compliance in letter and spirit.

Immediate action to be taken for enforcement of Model Code of

Conduct after announcement of General Election.

With the announcement of bye-election to 26-Serchhip(ST) AC the 'MODEL CODE OF CONDUCT' comes into immediate effect within the entire Serchhip District. Therefore, for effective enforcement of provisions of MCC, it is hereby iterated certain provisions of the Model Code of Conduct for strict compliance:-

- 1. Defacement of Government property In line with provisions under the Mizoram Prevention of Defacement of Public Property Act, 1995. All wall writing, posters/paper or defacement in any other form, cutout/hoarding, banner, flags etc., on Government property shall be removed within 24 hours from the announcement of election. For this purpose a Government premise would include any Government office and the campus wherein the office building is situated, including the outer face of the boundary wall.
- 2. Misuse of official vehicle There shall be a total ban on use of official vehicle by any political party, candidate or any other person connected with election (except officials performing any election related official duty) for campaigning, electioneering or election related travel during elections (subject to certain exception mentioned therein). The expression 'official vehicle' means and shall include, any vehicle used or capable of being used for the purpose of transport, whether propelled by mechanical power or otherwise and will include trucks, lorries, tempos,



- jeeps, cars, auto rickshaws, e-rickshaws, buses, belonging to Central Government, State Government/UT Administrations, Public Undertakings of Central/State Government, Joint Sector Undertakings of Central/State Government, local bodies, Municipal Corporations, Marketing Boards, Cooperative Societies or any other body in which public funds, however small a portion of the total, are invested.
- 3. Photograph of political functionary on display All references of Ministers, Politicians or Political Parties available on Central/State Government's official website, posters, banners or calendars shall be removed or concealed. Special mentioned is made of Mizoram Calendar 2021, published by I& PR Department, GOM in which photograph of high dignitary politician is on display on March page. This shall be either removed or concealed till the enforcement of MCC.
- 4. No Protocol by Government Officials: Officers of State Govt. and District Administrations shall not receive, see off or call upon, by way of protocol, on the Minister at the center or of the state when they visit the District on election related tour. By any means, officials programme and political programme should not be mixed.
- 5. Development/Construction related activities Within 72 hours of announcement of elections, a list of works for reference in case of validating any complaint on violation of MCC is to be submitted to District Election Officer. i,e. on or before 19th March, 2020 by 05:00 PM:
  - (i) List of work which has already been started on ground.
  - (ii) List of fresh work which has not started on ground.
