4. I undertake to bear all transportation expenses for myself and/or the person(s) for whom I have applied permission for entry in case the need to shift to a hospital / or any other facility arises as prescribed by Health authorities.

I undertake to abide by all instructions and protocol prescribed by the State Government, and I am fully aware that failure to do so on my part will invite penal action under the Disaster Management Act, 2005, the Mizoram (Containment and Prevention of COVID-19) Ordinance, 2020 and relevant provisions of the law.
