- 1) Containment Zone/Area puan dan : Covid-19 hri darh hlauhthawnawm a awm chuan Medical Department-in assessment an neih hnuah Deputy Commissioner, Hnahthial hnenah Containment Zone/Area-a puang tura recommend-na a thawn ang a, Deputy Commissioner in a tul dan angin Containment Zone/Area-ah a puang ang.
- 2) Containment Zone/Area puanna order a chhuah veleh Medical Team ten Containment Zone/Area a hmalak dan tur duante chak takin an kalpui nghal ang.
- 3) Containment Zone/Area puan a nih veleh Superintendent of Police in Security Duty a ruahman ang a. Security Personnel te hi Office hours chhung chu an duty tur a ni. VLTF te pawh khauh zawkin Containment Area chhungah an duty ang a. Tin, Office hours pawn lamah VLTF ten Security duty an mamawh anih chuan District Administration - ah an thlen ang a, District Administration in a tul angin hma a la ang.
- 4) Containment Zone/Area chhunga Covid-19 positive hmuhchhuah te chu a tul dan a zirin CCC/4C/DCHC - ah dah tur a ni.
- 5) Active Case Search (ACS), Contact Tracing leh Swab Sample Test result atanga Containment Zone/Area tihzim theih (Micro Containment Area) a nih chuan Medical Department – in Deputy Commissioner hnenah recommendation an thawn ang.
- 6) Containment Zone/Area-ah phalna neilote tan mahni in atanga chhuah khap tlat a ni. Thenawm khawveng inlenpawh, chawhmeh insuah leh chhan dang avanga intlawhpawh phal a ni lo.

- 10) Containment Zone-a loh theihlohna avanga lut leh chhuak tur, exempted category zinga mi nilo te chu VLTF ten Contact Tracing-ah an fihlim a ni tih hriatpuina lehkhana nen District Administration - ah an dilsak thei ang.
