8. Pawn lam atangin a bika ei leh in tur inpek phal a ni lo.
9. Quarantine Centre Attendant ruat a ni a, ani hian ni tin darkar 24 chhung a vil thin dawn a ni.
10. Quarantine Management Team din a ni a, anni hian Quarantine-a awm te chungchangah District Administration an puibawm thin ang.
